

TERMS AND CONDITIONS

Promoter	The Promoter is Parchem Construction Supplies Pty Limited (ABN 800 699 61 968), a division of DuluxGroup (Australia) Pty Ltd, located at 1956 Dandenong Rd Clayton 3168, Victoria, Australia.
Promotion Type	Game of Chance
Promotion Period	The Promotion will commence at 12:00AM AEST on 24 August 2026 and will close at 11.59PM AEDST on 20 November 2026 (Promotion Period).
Participating Store	Stores participating in the Promotion are selected Fosroc Distributors, Agents and Fosroc Trade stores nationally. Participating Stores will display promotion materials. If in doubt, an entrant may ask a store whether or not they are participating in the Promotion.
Entry restrictions	This promotion is only open to residents of Australia who are aged 18 or over. Employees (and their Immediate Families) of the Promoter, the Participating Store or its parent companies, subsidiaries or affiliated companies, or any agencies associated with this promotion are ineligible to enter. "Employees" means any directors, management, employees, consultants, officers and contractors or other such people who perform work under the control of another in exchange for payment.
